

2008 - 29th Annual Three Blind Mice Dollhouse Miniature Show

WE, THE THREE BLIND MICE, HERE AFTER, REFERRED TO AS 'LESSOR', ARE PLEASED TO ANNOUNCE THE 29<sup>th</sup> ANNUAL THREE BLIND MICE DOLLHOUSE MINIATURE SHOW. WE THINK YOU WILL FIND THAT AT HARA ARENA EVERY VENDOR WILL HAVE PLENTY OF SPACE, THE LIGHTING WILL BE EXCELLENT, PLENTY OF FREE PARKING FOR BOTH VENDORS AND CUSTOMERS, AND BEST OF ALL PLENTY OF CUSTOMERS.

**TABLES:** All tables are **eight feet(8')** long. One or two chairs are included per booth. Vendors must provide their own fire retardant table covers to the floor. All boxes stored under tables must be covered. Vendors may not extend booth space beyond 8' boundary.

**FEES:** Table fees are **\$140.00 each if paid after January 1<sup>st</sup> 2008. \$125.00 each if paid before January 1<sup>st</sup>.** No tables can be used at the end of your table to extend your selling space. Electricity is included at no extra charge. Also management reserves the right to offer special discounted prices for more than one table.

**REFUNDS:** If vendor cannot attend the show, for whatever reason, vendor understands that he will forfeit his payment for the tables(s)if the Three Blind Mice show managers are not notified by July 1<sup>st</sup>, 2008

**SET UP TIMES:** Vendors may set up Friday from noon. to 8 P.M. and on Saturday from 7:30 to 8:30 A.M. No set up allowed after the show opens on Saturday.

**DOOR PRIZES:** Each dealer is asked to donate a door prize.

**SHOW TIMES:** Doors open at 9 A.M. on Saturday, and 9 A.M. on Sunday and close each day at 4 P.M. Vendors are asked to not remove or pack any merchandise until the show closes at 4 P.M. on Sunday

**FOOD & BEVERAGE:** HARA ARENA NO LONGER ALLOWS ANY FOOD OR BEVERAGE TO BE BROUGHT INTO THEIR FACILITIES DURING THE SHOW. Food and beverage will be available at the concession stand during the show.

**TAX COLLECTION:** It may be necessary to purchase a State of Ohio Vendors License. Taxes are the responsibility of each exhibitor, not the show manager. Vendors who do not pay taxes currently in Ohio must obtain a Transient Vendor's License available through the website.

**PUBLICITY:** Publicity may include local radio and TV spots and all major miniature magazines. Direct mail flyers will be sent to prior years customers and possible new customers. Online advertising will also be ever increasing. Pictures and video may be taken at the show for use in show promotions. If you do not wish your images to be used please see the show manager for an opt-out form.

**PARKING:** Large, free parking lot. Space is available for RV's at a nominal cost, from HARA. Electricity is provided.

**MERCHANDISE:** Sales are limited to dollhouse miniatures, accessories and related items suitable to the character of a show of this type. The lessor reserves the right to order withdrawal from display any and all articles which do not meet these requirements. ALL MERCHANDISE WILL BE SOLD AT FAIR MARKET PRICE. NO DISCOUNT SIGN ALLOWED ALL ITEMS SHOULD BE PRICED.

**SECURITY:** 24 hour Security will be provided. **SMOKING IS NOT ALLOWED IN THE SHOWROOM.**

**SPECIAL INSTRUCTIONS:** If vendor wishes a particular location, or table arrangement, please specify on the contract. Lessor will do her best to meet vendor's requests, but cannot guarantee to do so.

**OTHER INFORMATION:** Badges, signs and vendor lists will be provided.
