We try our best to find excellent locations that offer plenty of space, good lighting and best possible accommodations for both vendors and customers.

**BOOTHS:** Tables offered are either eight feet(8') or six feet(6') long unless otherwise noted. Please make your selection on the attached CONTRACT. Amounts of each are usually limited and sometimes must be preordered well in advance of the shows. Please submit your contracts in advance with the desired table size and amounts for us to create and floor plan and order any needed tables.

One or two chairs are included per booth. Vendors must provide their own table covers to the floor. All boxes stored under tables must be covered. vendors may not extend booth space beyond purchased table length boundary.

**FEES:** Table fees vary by location and are noted in the CONTRACT. Electricity is included at no extra charge at most locations. If a fee is required at a location it will be noted in the CONTRACT.

**REFUNDS:** If vendor cannot attend the show, for whatever reason, vendor understands that they will forfeit their payment for the tables(s) if the Three Blind Mice show manager is not notified at least 30 days prior to show date.

**SET UP TIMES:** Vendors must set up during the posted 'set up' times. No set up allowed after the show opens.

**DOOR PRIZES:** Each vendor is asked to donate a door prize but is not required.

**SHOW TIMES:** Vendors are asked to not remove or pack any merchandise until the posted show end time unless special circumstance warrant. Please see Linda if the need arises.

**FOOD & BEVERAGE:** Most locations include a Food and beverage (F&B) contract with the facility. No outside F&B will be allowed at that facility but will be made available at the concession stand during the show in such case. Most locations with such contracts will have some meals provided to the vendors.

**TAX COLLECTION:** It may be necessary to purchase a Transient Vendors License for the state the show is held in. Taxes are the responsibility of each exhibitor, not the show manager. Vendors who do not reside or pay taxes in the state must obtain a Transient Vendor's License.

**PUBLICITY:** Publicity may include images or video published on internet, local radio, TV, newspaper and all major miniature magazines. Post cards will be sent to prior years customers and new customers.

**MERCHANDISE:** Sales are limited to dollhouse miniatures, accessories and related items suitable to the character of a show of this type. The lessor reserves the right to order withdrawal from display any and all articles which do not meet these requirements. **ALL MERCHANDISE WILL BE SOLD AT FAIR MARKET PRICE. NO DISCOUNT SIGN ALLOWED ALL ITEMS MUST BE PRICED.**

**SECURITY:** 24 hour Security will be provided in some form at each location.

**SPECIAL INSTRUCTIONS:** If vendor wishes a particular location, or table arrangement, please specify on the contract. Lessor will do her best to meet vendor's requests, but cannot guarantee to do so.
